Spectrum Holds Dedication for New Women & Children's Center

Spectrum Health Systems officially dedicated its new, \$2.5 million, 18,000-sq.-ft. Women & Children's Center, naming the facility Giblin House in honor of Kevin Giblin, a long-time supporter and generous donor to Spectrum's mission.

The dedication was held along with an open house at the new building on Friday, May 7, 2010 — a fitting start to Mother's Day weekend. The events culminated a nearly decade-long capital campaign and more recent construction phase which would not have been possible without the support of Mr. Giblin, numerous private and community foundations, Spectrum employees and many generous individual donors.

The impressive result of years of hard work is a debt-free, state-of-the-art facility which will provide a dignified, safe and secure environment where women learn to care for their children and function effectively as parents. The new building allows the expansion of the program's current capacity from 15 to 26 women and a maximum of 13 children up to the age of five.

Guest speakers included U.S. Rep. James McGovern; State Senator Jennifer Flanagan, chair of the Joint

Committee on Mental Health and Substance Abuse; Kevin Giblin, president & CEO of Brendon Properties; and Women & Children's Center alumna Sarah Lisa Kennedy.

"I learned I could be a wonderful woman, mother, sister and friend," Ms. Kennedy told an audience of over 150 guests about her experience at the Women & Children's Center. Ms. Kennedy credited the support of Spectrum staff and the other women she met in the program with helping her regain a life that today finds her living in her own home with all five of her children — and four years into recovery.

On February 23, 2010, Spectrum Health Systems presented Massachusetts Parole Board Chairman Mark A. Conrad with an award recognizing his advocacy, service and commitment to individuals and their families affected by substance abuse in our communities.

At a lunch presentation held at Spectrum's corporate offices in Worcester, Chairman Conrad said, "It costs tax payers in the Commonwealth approximately \$45,000 a year to incarcerate an individual serving his or her sentence. Compare that to \$24,000 a year to provide community treatment to an individual and see that they receive services that address issues such as substance abuse and mental health. It just makes sense."

Chairman Conrad described the work of substance abuse and mental health treatment providers such as Spectrum Health Systems as being crucial to the Parole Board achieving a success rate of 78 percent for individuals under community supervision in 2008. According to the Bureau of Justice Statistics, the national average rate for successful parole completion in the nation is 49 percent.

Personal Story

Tracy is one of the latest proud graduates of Spectrum's Women & Children's Center, completing the program in the summer of 2010. Her battle with heroin addiction spans more than ten years, beginning with



prescription drug abuse when she was 28 years old.

Tracy came to the Women & Children's Center from MCI Framingham. At

that time, she had served six months for larceny, and her three-year-old son, Justin, was in foster care. Released to the Center with the understanding that she would be working towards reunification with her son Justin, Tracy vowed to herself to make changes in her life.

She credits Spectrum with providing her the tools to accomplish the hard work of being honest with her self, seeing what was unmanageable in her life, and how to change it. "They believed in me, even when I sometimes didn't believe in myself," says Tracy.

Tracy also credits the support of her fellow clients at the Women & Children's Center, saying, "They're like sisters to me. We work off of each other, we're very supportive of each other, and it's a family and community atmosphere."

After learning to change the unhealthy choices she was making that kept her from her son, Tracy was reunited with Justin permanently in the winter of 2010 through a process facilitated by Spectrum and the Massachusetts Department of Children and Families.

Before graduating, Spectrum staff assisted Tracy with reentry planning, which included transitional housing. She is moving into sober housing with Justin and has plans to go back to school and save money for permanent housing. Then she would like to be joined by her other two sons, Patrick, 12, and Jared, 15. She is currently rebuilding her relationships with them while they live with her father.

With a work history that includes bookkeeping, Tracy is exploring her job possibilities, but says with certainty, "I want to be a parent to the best of my ability. That's the most rewarding job you could have."

Meeting CLIENT'S NEEDS

Spectrum's Training Programs Benefit Staff and Correctional Officers Alike

With a network of corrections-based substance abuse treatment programs currently operating in eight states, Spectrum's comprehensive staff training program ensures that all staff are adequately prepared to fulfill their job responsibilities and provide the highest quality of service. All training is CEU approved and competency-based.

Spectrum recently provided a number of week-long intensive training sessions for counseling staff working throughout the Massachusetts state prison

system. The main purpose of the conference was to educate paroling/releasing authorities about research, current topics and practical information to improve professional skills.

Success at Georgia CRA Program

The Correctional Recovery Academy (CRA) program at Coastal State Prison in Georgia recently graduated its first three peer leaders. These graduates started the program in late 2009. Since then, over 200 peers have joined this CRA community.

Residential Substance Abuse
Treatment Program Director Rhoda Kimble said, "We are extremely proud of these graduates. Through the ups and downs of implementing our structured programming elements, each of them exemplified great leadership skills and was consistent in their recovery efforts."

Spectrum Programs in Maine Receive Highest Rating

Spectrum's in-prison residential treatment programs in Maine underwent two licensing reviews and received five commendations for mental health and twelve commendations for substance abuse. The Maine Department of Health and Human Services' commendations included Spectrum receiving the highest rating ever recorded in the state using the Correctional Program Assessment Inventory tool.

In addition, a recent study of inmates released since 2006 indicated that inmates completing Spectrum's Correctional Recovery Academy program in the state were 50 percent less likely to recidivate than inmates from the general population. The study was conducted by the University of Southern Maine Muskee School of Public Services.
